Kingston Council is committed to building a new swimming and leisure centre in Kingston town centre, and has been working at pace to bring forward revised proposals for the centre.

Accessible, inclusive and sustainable facilities remain at the heart of the project that will deliver the range of activities that residents and stakeholders said they wanted to see, in a more efficient two-storey building created within an affordable budget.

A design team was brought on board to create the revised proposals.

In July 2024 the public were invited to meet the team, ask any questions, and let the Council know what they think about the new designs for the leisure centre, through a range of methods as described in section 2.0.

The events aimed to:

- Update stakeholders on the new approach to the proposals
- Show the updated designs, key features and show how previous feedback has influenced them
- Show the landscaping proposals and the suggested building materials
- Answer questions that were raised in the previous round of feedback
- Set out an updated timeline for the project







Do you like the design of the building?

The response to Question 1 is overwhelmingly positive, with 170 out of 210 responses saying they like the design of the building.

14 people said 'No', they didn't like the design, and 26 were unsure. All of the 'No' responses came from respondents completing their feedback online, which suggests that those seeing the designs in person and having them explained by a member of the team allowed them to understand the plans more easily. Some online respondents said that the plans were hard to read online which made some details hard to understand.



Question 2:

What do you think of the facilities and spaces on offer inside of the building?

There were 160 responses to this question. 136 responses were positive, and 24 were negative/critical.



Respondents were excited about the prospect of the new centre, with the wide range of facilities being well received. People mentioned that the designs appear to be well thought out and tick lots of boxes. There was a general acknowledgement that the designs include as much as possible within the footprint and budget. Negative 🙁 24 responses

The few negative/critical responses were more related to specific facilities that commenters felt were missing, as opposed to any negative comments about the overall design of the centre. Some felt as though the designs were 'over complicated' and that the pool is the most important aspect and should therefore take precedence over less important features.

"I think the appearance looks good, so much better than the previous plan. It looks open and welcoming and will be a real asset to the area"

"I really like the facilities and I'm looking forward to using them. So much space for everyone"

"Health suite is white elephant. That space could be better utilised. If people want that it's all ready available in the borough. It'll cost loads to run (heat etc) and maintain."

"Far too many facilities which I think will be under used."

Key themes for question 2:

Swimming pool (61 comments)



Overall respondents were happy with the plans for the pool, with many saying this was the most important aspect of the centre and has been sorely missed in the borough.

- A few said they would like the pool to be bigger, with other facilities in the centre reduced to allow for this.
- Some comments mentioned a lack of detail in the plans for the showers and changing areas, particularly the quantity and size. Some respondents preferred separate areas as opposed to mixed gender changing rooms etc, citing safety concerns.
- Many still lament the lack of 'fun' elements for children, in particular the wave machine.
- Some suggested the addition of pigeon holes and hooks to store beside the pool for personal belongings while swimming.
- Respondents had concerns about the sauna / steam room not being adjacent to the swimming pool and meaning that users have to dry off / get dressed to get to the sauna. 5 comments also addressed the lack of hydrotherapy pool and jacuzzi.

Accessibility (16 comments)



- Although comments appreciated that the plans take into account feedback from local disability groups, they also felt that more could be done for neurodivergent centre users and those with multiple disabilities.
- The two spaces allocated for Blue Badge holders was deemed insufficient by several respondents, and some felt this would be a barrier for visiting the centre for disabled people.
- One commenter in particular raised the question of parking mobility scooters and navigating the centre in one.
- Aids for people with sight issues, i.e. high contrast black and white areas to guide swimmers with sight loss, and textured tiles near the pool to help them navigate by touch.



Question 3:

How will you travel to the leisure centre?

Walking was the most popular form of transport, with 118 people choosing this option. Second and third were bus and cycling, respectively.

A total of 132 people skipped this question, or commented that they didn't have any ideas for reducing energy use. The goal to become an energy efficient centre was viewed positively. Of the 79 that did provide answers:

Solar panels were the most suggested, with an acknowledgement that there are already some included in the plan.

The second most mentioned idea was **water recycling**, i.e. using recycled shower water for flushing toilets and using collected rainwater to water plants.

The third most mentioned idea was using a **ground source heat pump** for heating the swimming pool and the wider centre.

Other ideas included using **kinetic energy produced from exercise bikes** and mats at entrances, **sensor / automatic lights that go off in rooms when not in use**, and secure cycle storage / incentives for cyclists and other methods to dissuade people from driving to the centre.

Question 5:

Do you have any further comments about the proposals?

Key themes for question 5:

Car and bike access / parking (30 comments)



- Comments were made about there not being enough bike spaces.
- Covered and secure bike parking was popular to avoid bike theft, with the addition of a pump and repair tools.
- Safety of parking and location of coach parking beside the playground was questioned and deemed unsafe by some.
- Several thought that two disabled parking spaces was insufficient.

"I am put off by the parking bays and coach parking immediately next to the centre. These must be further away to ensure the surrounding space is safe and inviting for pedestrians."

"I know if the bike storage was more secure then I would definitely cycle. Lockers for foldable bikes would be useful too."

KINGSTON

Speed of build (29 comments)

- Respondents are keen to see the project move quickly and this was reflected in the feedback, 29 people mentioned the speed of the build.
- Some comments asked if it was possible for the centre to open in stages to allow for earlier access to certain parts.

"I feel it's important that the build is well managed so that the opening target date is realistic and achieved. We have gone without a pool for too long."

"Please ensure that any timescale for the work to commence are not overrun. Residents of Kingston have waited a very long time for this."



Links to Fairfield and environs (30 comments)



- Commenters said it was important to consider the leisure centre in the context of the wider area as the site feels isolated from the main centre, and to link to the Kingston Town Strategy.
- There were suggestions to maintain / enhance links to the Fairfield green space, museum and library to drive footfall, and provide adequate wayfinding at the same time.
- Some requested that exercise activities could spill out onto the outdoor space around the centre, with classes taking place under a covered area.

"Everything we do on The Fairfield is connected - it is Kingston's green lung and the Centre is just one aspect of breathing good life into this precious resource."

"Shame there was no provision made in the proposals [for] an outdoor basketball hoop/ football pitch ... or even an outdoor table tennis table."

Question 5:

Do you have any further comments about the proposals?

Key themes for question 5:

Affordability (13 comments)



- It is important to people that the leisure centre facilities are affordable to all.
- Some commenters mentioned concessions for older people and those living in the borough.

"Please make the costs affordable and offer a range of subscriptions for customers who live in and out of the borough plus those who work within Kingston"

"I worry about the cost of membership or price to be able to use the facilities. There are loads of gyms around in Kingston that offer gyms, swimming pools etc but [prices are not accessible for] the working community" Maintenance (7 comments)



- Although the plans for the garden and landscaping were well received, there was some concern about the provision of ongoing maintenance.
- There were also concerns about proper maintenance of the centre itself.
- Participants wanted confirmation that there would be adequate funding to prevent the centre and surrounding areas from becoming neglected.

"The maintenance of the centre is/ will be very important, we don't want to see a lovely design being neglected and run down because of lack of maintenance internally and externally."

"I have considerable reservations about how the outside areas will be managed and to what standard."

Feedback from Disability and Wellness Network Event

A dedicated event was held with Kingston's DAWN (Disability and Wellness Network), invites were sent to the Council's wider network of disability and carers groups. The event was attended by 9 people and included those with learning disabilities and staff that support those with disabilities.

The project team gave a presentation/talked through the boards and took questions from attendees. Overall the session was very positive. Many participants intended to provide feedback online after the event, and any feedback given online will be summarised as part of the overall feedback sentiment shown in this report.

Summary of DAWN session feedback

The following is the headline summary of the conversation collected by RBK officers.

It was noted that the design team have kept in mind current and future sporting guidance, bringing on expertise for specialist disabilities advice. The team have considered lived experiences, and the journey to and around the site of different user groups. The building will be a canvas for the operator, and there are many uses for the space.

- Accessibility both inside the building, for example the size of the lifts, the layout being simple, and visual with minimal corridors, and accessibility to get to the building. Outside the building pathways for pedestrians should be wide, clear access, a path to the bus stop and disability parking as close as possible to the entrance.
- For accessibility the layout of the building should include clear corridors with fire extinguishers and bins set into walls.
- Ensure lighting is suitable for those with sensory disabilities and impairments, and the noise level is controlled for those with hearing impairment or sound sensitivity/ autism.
- External lighting around the centre, including on the pathways to the building.
- Storage space for specialist equipment: one attendee asked for water cycling equipment as she currently needs to go outside the borough for sessions.

- External and internal signage for those with visibility impairments. Embossed large signage at eye level on toilets doors, changing rooms and fire signs not above doors.
- Consider colours for visibility: including colour contrast floors, colours of the furniture, walls, doors, lockers and catering equipment.
- It is positive that the learner pool area (including changing rooms) can become a fully private experience, which will be useful for women's only sessions, amputees, and for any other group that would like privacy.
- Wheelchair users acknowledged the access to both pools via steps and the option of a hoist.
- It was recommended that all staff should receive disability awareness training.

Specific engagement with young people

In order to encourage responses from younger people in the borough, we created a specific engagement activity that they could complete. The standard online survey was of course open to all ages for completion should they wish.

The activity offered the chance to provide ideas for how respondents wanted to use the new public spaces that would be available, what types of play equipment they would want to see, and any colours or patterns they would like to see used as part of the landscaping design.

The engagement task was available at all events, used at young people focused meetings and sent to all schools in the borough during the engagement window.


Members of the project team also attended Kingsnympton Youth Club, and the engagement task was completed by attendees of the SEND children and young people's participation group.







Postcode data


130 respondents provided us with postcode data. From this we can see:

- 63% of respondents (that provided a postcode) live within a 1 mile radius of the site
- 85% live in the borough of Kingston

Demographic data


We have tracked and compared the data given with local averages (based on 2021 Census data for the borough of Kingston). Of the 215 people who gave feedback, **210** gave some demographic data (shown on following page).

ETHNICITY: 208 responses

KINGSTON

The majority of participants were White British or White other and when compared to borough data all other ethnicities were under represented. Participants of Mixed/ Multiple ethnic origins were under represented by 0.4% and Black/ Black British/ Caribbean or African was under represented by 0.8%. However there was a greater under representation of Asian/ Asian British participants.


AGE: 210 responses

People under the age of 34 were under represented. Under 16s represent 17.6% of the borough's population and were not reached through the feedback gathering process. People aged 35 - 64 were over represented in the feedback showing that the current communication methods are reaching that demographic.

The Council worked hard to reach out to younger people and voices with a specific activity. Being forced to change the engagement window into the summer holidays also changed the plans around this.

Conclusion



Conclusion

The events were well attended and the volume of online feedback shows that this project is important to the residents of Kingston.

Key feedback:



The pool has been well received and respondents were happy to see it given a prominent place in the centre, with many seeing this as the most important part of the facilities, however many said that they would like to see fun elements that the previous centre included.



The current parking layout could be reconsidered with more spaces for Blue Badge holders and also move the coach parking away from the play area.



Secure cycle parking is also a popular request and will help to dissuade driving to the centre if this is adequately provided for.



Although there is acknowledgement that a good effort is being made to cater for those with disabilities, there are still **accessibility issues** to address in order for disabled and neurodivergent people to be able to use every part of the centre.



Survey respondents are keen to see the new centre **built as quickly as possible**, with regular updates and transparency around the timeline.



Other points of concern/ interest include:

- Adequate maintenance of the internal and external spaces.
- Considering links to the Fairfield and wider context.
- Provision for older children/teens
- Importance of affordablility for those living in/out of the borough.



In a change from the previous project, we have brought our construction partner on board at a much earlier stage. This is so that we are able to have more concrete assurances around costs and programme as the project progresses to completion.

Leisure experts Pellikaan have been appointed as the construction partner for the project, and this will be one of the over 110 projects they have helped to create in the UK. They have input into the design of the scheme to ensure that it is deliverable within the budget we have, and are confident on the timescales for construction.

The project continues to be **overseen by Alliance Leisure**, utilising the UK Leisure Framework to bring on board **a team of high quality consultants for the scheme.**






Ground floor plan



The ground floor has a welcoming entrance and café, a soft play area, 3 exercise studios and the two pools with wet changing facilities that look out onto the newly landscaped space.













We aim to create a building centred on economic, social, and environmental sustainability. By following principles that consider the entire life-cycle and reuse of materials, we will be using on-site renewable energy to help us achieve our carbon net zero targets. The design maximises daylight, integrates with nature, and uses existing trees for shading, meeting the highest sustainability standards. Below are some of the key ways in which we are designing a sustainable, future-proof leisure centre for Kingston.

Key sustainability features

Operational energy:

Refers to energy a building consumes during use, including heating, cooling, lighting, and powering appliances. Our design is sustainable in this regard:

- Aiming for "excellent" BREEAM, a top sustainability standard.
- Passive design for natural light and ventilation.
- Low-energy systems for heating, cooling, and lighting.
- Promotes accountability for energy use.
- Uses zero carbon energy sources.
- Designed to adapt to future climate changes.

On-site renewable energy:

- Photovoltaic (solar) panels on roof to generate energy.
- On site battery storage for peak demand.

Improving biodiversity:

- Minimum 10% Biodiversity Net Gain.
- Urban Greening Factor improve the existing green infrastructure.

Environmental management:

- Permeable landscaping and Sustainable Drainage (SuDS) to slow and manage surface run-off.
- Connection to a district heating network.





Thank you to the 278 people who attended our events in January 2024. 125 of you gave feedback in person as well as 152 people who responded online.

We appreciate all of your feedback, here are our responses to key questions and comments raised.

Your top priorities



The **25m competition pool** was overwhelmingly ranked most important by the majority of respondents.



The **learner pool** was the second most popular element.



The **fitness gym** was the third most important part of the leisure centre to those who responded.

Answering your questions

<u>Indoor</u>

Swimming pool:

- What fun elements will be included in the pool?
- Both swimming pools will have a moveable floor installed, with the learner pool able to be changed into a splash zone with lights and water fountains.
- How does the moveable floor work?
- A moveable floor in a swimming pool floats on top of the water and is pulled down by stainless-steel cables. The floor has holes in it like a sieve and the water passes through the floor to adjust to the desired height.

• Is it possible to provide a hydrotherapy pool?

 The overwhelming message from residents is that a main swimming pool and learner pool are required in Kingston and this is what is being delivered. For a hydrotherapy pool to work correctly, consultation rooms and other facilities are required, and we do not have the space available on the site. It is also not possible to heat either of the planned pools to the required temperature. The temperature of the learner pool will be warmer than the main pool, making it more appropriate for people that may need to move more slowly, whilst meeting the needs of as many people as possible.

• Will the swimming pool and changing rooms be accessible?

 Providing opportunities for people of all abilities, ages and backgrounds to participate in sport, leisure and community focussed activities is one of the key aspects of the project. Accessible changing rooms and toilets will be provided for wet and dry activities. A Changing Places toilet will also be provided in the facility. For more details please see information board 7.

<u>Outdoor</u>

Public realm:



- How will you ensure the maintenance and upkeep of the plants?
- The maintenance and upkeep of the landscaped areas will be included in the Council's existing Grounds Maintenance Contract.

• What is Sustainable Drainage and is it safe?

 Sustainable Drainage (SuDS) offers a more natural approach to managing drainage systems in and around developments than traditional drainage systems. The majority of the time this area will be dry and it will only hold water for a short period of time following heavy rainstorms before naturally draining away into the ground.

Play:

- What will happen to the play area during construction?
- The existing play area and green space will not be available during construction. However, we understand that this is a well used play area and will be providing alternative play facilities in Fairfield Recreation Ground. The Council's Green Spaces team will consult on the mix of equipment. It will be installed before the existing provision becomes unavailable, and will remain in the Fairfield after the new leisure centre is built.

• How will the play space cater to a range of ages?

- The play area will cater for 0-8 year olds in line with the existing provision.
- Can we have outdoor football/netball/basketball courts?
- There is not the room on the site to offer these facilities and they are available at other locations across Kingston.

Sports hall:

• What kind of sport will be possible?

- In line with the feedback that has been received telling us the activities people want to take part in, the sports hall has been designed to accommodate the following:
- 5-a-side football
- Badminton
- Basketball
- Cricket (nets)
- NetballPickleball
- Volleyball
- Table tennis

Parking:

- How will you accommodate the level of car and cycle parking required?
- Car parking will be met through the existing car parks in the town centre, including the Cattle Market car park. Cycle parking will be provided in line with planning regulations to meet the needs of both staff and users.


• Why is the coach parking next to the play area?

• Coach parking is required to support the delivery of school swimming lessons and events such as swimming galas. The location of the children's play area has moved to a more prominent, safe, location.
